

QUADRO COMMUNICATIONS CO-OPERATIVE INC. HIGH-SPEED INTERNET SERVICE REQUEST

OWNED EQUIPMENT LEASE AGREEMENT

This agreement is entered into by and between Quadro Communications Co-operative Inc. hereinafter called **QUADRO**, and

_____, Hereinafter called the **LESSEE**.

WITNESSETH:

WHEREAS, LESSEE desires to lease certain equipment listed before from Quadro and

WHEREAS, Quadro desires to lease the equipment to the LESSEE:

NOW THEREFORE, both parties agree as follows:

CONDITIONS:

- 1) LESSEE will plug the equipment left in its custody into a surge protector, through both power and phone lines.
- 2) QUADRO will be responsible for replacement of equipment, which may fail as a result of normal wear.
- 3) LESSEE shall insure the equipment for all risks from the time it is removed from Quadro until it is returned. Insurance will be for the replacement amounts listed.
- 4) Equipment shall remain in the possession of the LESSEE for the period to time that the LESSEE requires the equipment in order to receive High Speed Internet Access.
- 5) In exchange for the use of the equipment, the LESSEE agrees to compensate Quadro by subscribing to High Speed Internet access for a minimum three-month period at the rates as posted by Quadro from time to time until the equipment is returned. The wireless customer is exempt from this minimum due to the pre-payment arrangement.
- 6) LESSEE, shall at its cost, return the equipment to Quadro upon termination of High Speed Internet Access service to 1845 Road 164, KIRKTON, ON or 485 James St S, ST MARYS ON.
- 7) LESSEE will be liable for the full value of the equipment as listed below should it not be returned immediately upon termination of High Speed Internet Access.
- 8) LESSEE acknowledges payment is due the 28th of each month and defaulting on a payment shall result in immediate suspension of service.**
